#### Student

This student has been through the PARCCA and RISe programs into Benjamin Franklin Middle School. His behavior is becoming more and more aggressive. He has injured the teacher twice (concussions). Additionally, the student would bang his own head against the wall. The student was placed on home instruction. The parents sought mediation because they felt the Ridgewood Board of Education was not providing a free and appropriate public education. Ms. Huntington recommends the settlement, including the placement.

Student \_\_\_\_\_, an eighth grader, is autistic with a seizure disorder. The student has become aggressive and the parents want the child placed in \_\_\_\_\_. The district originally offered to pay for education only – no residency - which the parent rejected.

Mr. Rubin, Board Special Education Counsel, has advised us we have a 50/50 chance of winning in court.

#### II. Hearing – Matter #1112001

Mr. Merlino explained the reason for holding this hearing and the procedures.

Ms. Aslanides reported the incident that began on September 9, 2011 when a group of Ridgewood High School students allegedly threw acorns at Student . The student was questioned by Ms. Aslanides and was not clear on the facts and reluctant to speak about the incident. In fact, Student had to be prompted by Ms. Aslanides to elicit the information. The accused students claimed they were aiming at a tree and were not targeting the student.

The parents of Student had complained to Mr. Lorenz about their child's treatment prior to Wednesday, September 7, 2011. They claim their child also had trouble with students in Benjamin Franklin Middle School; however, the students accused in this incident were mostly not part of this middle school group. The Superintendent's finding was there was no violation of HIB.

At 7:02 p.m., the parents of Student joined the meeting. Mr. Merlino explained the process and standards for the hearing and the role of the parties present and the parents.

The father of Student asked if this was the first HIB case. Mr. Pizzuto responded this was the first hearing, not the first investigation. The father expressed his disagreement with the definition of HIB. He stated that his child was subject to having rocks thrown at him as well as being called names. The parents said this treatment happened earlier in Student school career.

Mr. Pizzuto explained that the high school's procedures for dealing with this situation would be different than what is required by HIB laws. The "other" procedure is not as adversarial and is more parent friendly than the HIB procedure. Representatives from the high school suggested the parents come to the high school so everyone could work as a team to develop the best strategies for each student.

The parents expressed their concern that the "harassment" would continue and did not agree with the outcome of the investigation. They stated there have also been instances of verbal abuse.

EXECUTIVE SESSION NOVEMBER 2, 2011

Ms. Aslanides and Ms. Yannone explained that just because HIB is not found it does not mean that the conduct was not inappropriate or that it will not be addressed in school. Ms. Aslanides stated that Ridgewood High School had a process in place before the HIB law went into effect and she believes the informal process is more effective.

At 8:05 p.m., the parents left the meeting.

Ms. Lenhard questioned why there was a finding of no HIB. Mr. Pizzuto stated that throwing acorns does not qualify for HIB because there was no motivation according to the definition of the law.

It was the consensus of the trustees present to uphold the Superintendent's recommendation.





# II. <u>Hearing – Matter #1112005</u>

Dr. Fishbein briefed the trustees on the situation and the requirements of the HIB law.

At 6:40 p.m., the parent and uncle of Student and Student joined the meeting. Mr. Merlino opened the hearing.

Student said there was no intent to hurt anyone's feeling. Student is uncle reiterated that the student meant no harm. He stated the law requires intent and he does not believe that hurdle was cleared. He believes other parties involved were not investigated or found "guilty" of the same act. The uncle claims Mr. Orsini informed him a violation was committed after the investigation was completed.

The uncle of Student stated the punishment is over the top and feels the students were singled out. He is not willing to have this judgment stand.

The family left the meeting at 6:55 p.m.

The trustees discussed the HIB findings with Mr. Orsini. Mr. Orsini explained the findings of the hearing and justified the reason for the HIB finding.

The trustees agreed to uphold the finding.
